MILLBURN OFFICE OF EMERGENCY MANAGEMENT DECLARATION OF LOCAL EMERGENCY / DISASTER

TO ALL CITIZENS AND PERSONS WITHIN THE TOWNSHIP OF MILLBURN, NEW JERSEY; AND TO ALL DEPARTMENTS, DIVISIONS, BUREAUS OF THE TOWNSHIP GOVERNMENT OF MILLBURN, NEW JERSEY.

Emergency Directive 2020-04

WHEREAS, pursuant to the powers vested in me by (Chapter 251 of the laws of 1942, as amended and supplemented, N.J.S.A. App A:9-30 et. seq.; N.J.S.A. 40:48-1(6), and ordinances enacted pursuant thereto; N.J.S.A. 2C 33-1 et. seq.; whichever law or laws apply, it is declared that a local Emergency/Disaster exists within the Township of Millburn; and

WHEREAS, the aforesaid laws authorize the promulgation of such orders, rules and regulations, as are necessary to meet the various problems which have or may be presented by such an Emergency/Disaster; and

WHEREAS, On May 1, 2020 Governor Murphy made an announcement that municipalities may open their tennis courts to the public in addition to State and County parks being permitted to open; and


WHEREAS, Emergency Directive 2020-02 issued on March 18, 2020 at 1530 hrs. will be amended to allow the opening of all municipally controlled tennis courts on Thursday, May 7th in accordance with guidelines set forth by the Township's recreation department. Municipal courts are located at Taylor Park, Gero Park and Slayton Field. There are COVID-19 Guidelines posted on the township's website; and

WHEREAS, private tennis courts or clubs will be permitted to only open their courts with guidelines and restrictions in place that conform to social distancing guidelines and any and all applicable Executive Orders issued by the Governor of the State of New Jersey. No clubhouses or other indoor facilities should be opened to their membership; and

WHEREAS, all parks will remain open with proper social distancing. All playgrounds and basketball courts will remain closed. All previous emergency directive items remain in full force and effect; and

WHEREAS, the provisions of this declaration can be amended at any time by the issuance of an emergency directive;


